- 3. The Regional Offices/Divisions concerned will issue the posting orders in respect of the officials allotted to the respective Regions posting them against the norm based regular LSG vacancies.
- 4. If any vigilance/disciplinary case is pending against the above named officials, they should not be relieved for posting without obtaining specific orders from this office. If any punishment is current, in respect of any of the above named officials he/she should not be promoted before the expiry of the currency of punishment.
- 5. In case the official is already placed in the Pay Matrix level 5 under the TBOP scheme or have been granted the first financial upgradation under the MACP scheme and got their pay fixed, they are not eligible for fixation of pay on this promotion. Others, if any, will exercise their option under FR 22 (I) (a) (1) for fixation of pay within one month from the date of issue of posting orders.
- 6. Promotion will take effect from the date of assumption of charge in the norm based LSG posts pursuant to this order and necessary charge report may please be forwarded to this office.
- 7. In case the officials refuse the LSG promotion now offered, they will not be eligible for regular promotion to LSG cadre for a period of one year from the date of such refusal and will not be

considered for officiating promotion in LSG posts. Such officials, if officiating in LSG, HSG II or HSG I posts, on adhoc basis, will be reverted immediately. Also the official will not be eligible for MACP placement in accordance with the provisions contained in Para 25 of Annexure I to Directorate Letter No. 4-7/ (MACPS)/2009-PCC dated 18.9.2009.

- 8. Wherever movement of officials is contemplated as per this order, they should be relieved within thirty days from the date of issue of posting order.
- 9. In case, if any official fails to assume charge in the promoted post, within a period of 30 days from the date of issue of posting orders, it will be presumed that he/she has declined the promotion offered.
- 10. In case any official is not willing to accept promotion, his/her representation declining the promotion offered should reach this office within 30 days from the date of issue of posting orders.
