

- 2. In case any vigilance/disc. case, of the type referred to in O.M. No. 22011/2/86-Eatt (A) dated 12.01.88 from DOP&T circulated vide Directorate Memo No. 25-19/88-SPG dated 01.05.88 (subsequently) revised vide DOP&T memo No. 22022/4/91 Estt. (A) dated 14.09.92 circulated vide Directorate Memo No. 25-19/88-SPG dated 13.10.92 is pending against the official, the official should not be relieved for posting without obtaining specific orders from the appropriate authority.
- 3. Divisional Heads will issue necessary posting orders in respect of officials allotted to the respective Division within 5 days of receipt of this order. Regional Office may ensure that the posting orders are issued by Divisions under their Region within the stipulated time period.
- 4. Those officials who have already been placed in the pay matrix level 5 under the MACP scheme and got their pay fixed are not eligible for fixation of pay on this promotion. Others if any, will exercise their option under FR 22(I)(a)(1) for fixation of pay within one month from the date of issue of posting orders.
- 5. Those officials who refuse LSG promotion now offered will not be eligible for regular/officiating promotion to LSG for one year from the date of refusal. Such officials are also not eligible for placement in MACP till they accept regular promotion.
- 6. Wherever movement of officials is contemplated as per this order, they should be relieved within thirty days from the date of issue of posting order.

- 7. In case, if the officials fail to assume charge in the promoted post within a period of 30 days from the date of issue of posting order it will be presumed that he/she has declined the promotion offered.
- 8. In case the officials are not willing to accept promotion, the representation declining the promotion offered should be received at the concerned Regional/Circle office within 30 days from the date of issue of posting order.
